All individuals who are actively interested in any field of molecular evolutionary biology are eligible for active membership in the Society. The Society sponsors an annual scientific meeting which will take place in 1997 from June 1 through June 4 at the Congress Centre, Garmisch-Partenkirchen, Bavaria, GERMANY.

Annual subscription membership in the Society for Molecular Biology and Evolution includes a subscription to *Molecular Biology and Evolution*, and members pay a lower registration fee than do non-members for participation in the annual meeting. Joint heads of household who both qualify for an individual membership may choose a family membership, which entitles each to be listed as a member and to vote and which entitles the household to receive a single subscription to *Molecular Biology and Evolution*.

Subscription Rates Annual individual membership in the Society for Molecular Biology and Evolution is \$10, Family, (two members at the same address who may receive a single subscription) \$20. Subscription rates for members: Individual or Family—\$60; Students (copy of student ID must accompany subscription request)—\$42. All subscriptions are on a calendar year basis and start with the January issue. AllenAir delivery is included in the rates for all subscriptions outside of North America.

Institutional subscriptions to the journal are at an annual rate of \$335.00. Institutions are not members of the Society and do not have voting privileges.

Submission of Articles Publication in *Molecular Biology and Evolution* is open to members and non-members alike, and acceptance of papers for publication after editorial review is decided solely on the basis of merit and suitability.

Send one original and two high-quality copies of the manuscript to the editorial office listed above. Proposals for review articles and book reviews must be discussed with the Editor prior to submission.

Authors may also send manuscripts of *original research articles only* directly to Associate Editors, whose addresses are given on the inside back cover of each issue. When doing so, in order to avoid unnecessary delays, authors should contact the Associate Editor prior to sending the manuscript. At the same time the manuscript is mailed, authors should notify the Editorial Office of the title, authors, contact information for the corresponding author, and the name of the Associate Editor. Regular mail, E-mail, or Fax are acceptable for such notifications. This notification will permit us to ensure that manuscripts are handled promptly and will prevent undue delays in the event that a manuscript is lost in the mail. In either case, if an author has not received an acknowledgment of the manuscript within 10 days after sending it, the Editorial Office should be contacted immediately.

Contributors should consult those instructions for detailed information about the format for manuscripts for *Molecular Biology and Evolution*. Manuscripts that do not conform to *Molecular Biology and Evolution* format will be returned to authors without review.

Page Charges There is a charge of \$35 per page or fraction of a page for the first ten pages for publication in *MBE*. For each page over ten, the charge is \$64 per page. These charges will be reduced to \$30 per page (and \$59 for pages in excess of ten) for final versions that are submitted with a disk. If the authors do not have the financial resources to cover these charges, a waiver of the charges may be requested of the Editor at the time that a manuscript is officially accepted for publication by the Editor. (Authors will receive a formal letter of acceptance from the editorial office.) Page charges will not be waived for pages over ten. Page charges will not normally be waived unless an electronic version of the manuscript accompanies the final, printed version which the Associate Editor sends to the editorial office with a recommendation for acceptance. Articles are selected without regard to authors' ability to pay page charges.
